 To discuss the strategy / procedure to implement Ability Enhancement Compulsory Courses in Semester 1 & II under CBCS.

#### Decisions taken in the meeting:

- It was unanimously resolved that the college shall adopt Choice Based Credit System from the current Academic Session 2015-2016.
- 2. The members approved the syllabi of (AECC) Courses: Communication Skills in English, and Environmental Studies for Semester I & II; members further agreed to frame syllabi of discipline specific courses, (minimum six in each discipline specific course) and skill enhancement courses (Four in each discipline); so that the student can choose from the list as per their choice. It was also resolved in the meeting that the college shall adopt AECC Courses on rotation basis for Semester-I&II (Science and Commerce/ Humanities).
- The Academic Council approved the syllabi of different subjects offered in the college which were prepared and approved by the respective Board of Studies.

#### Suggestions by the members:

Prof. Lokesh Verma suggested that two inter-disciplinary courses (Core Elective/Generic Elective) may be introduced in semester-V& VI. He emphasized on the importance of Foundation Courses/AECC, and Value Added Courses/SEC for the skill enhancement of the students. He further highlighted the need to introduce discipline related skills for each subject. He proposed that there should be a Common Minimum Content of the Courses across the Universities/ Colleges in the Country for smooth transfer of credits to students. He also deliberated on the nuances of CBCS.

- He showed his concern for providing a congenial atmosphere, and infrastructure for the smooth implementation of CBCS in the college. He also stressed upon maintaining teacher students ratio, and work load as per the UGC guidelines.
- Prof. M.K Jyoti suggested that teachers should keep on updating themselves, and also become technologically savvy.
- Mr. Annil Suri suggested that the course content of AECC Environmental Studies should be reduced. He further suggested that the E- teaching should be adopted by the teachers in the college on regular basis for which Communication Labs, and Internet facility should be provided.

All the members congratulated the chairperson Prof. (Dr.) Hemla Aggrawal on initiating CBCS.

The Chairperson Prof. (Dr.) Hemla Aggrawal welcomed the suggestion put forward by the members of the Academic Council.

#### Decisions taken in the meeting:

- 1. Resolved that with reference to the notification issued by the University of Jammu, dated August 11,2015 regarding admission of students in undergraduate Semester I and III 2015, the college shall also adopt/follow the same guidelines for the admission.
- 2. Resolved that the college shall also issue a separate notification regarding admission of students in Undergraduate Semester I and III, and get it published in leading local Newspapers. It was further resolved that as one time exception for this year (2015), only bonafide students of the college shall be given a chance for promotion from Semester I to Semester III, provided they fulfill the other eligibility conditions, and have passed at least 50% (instead of the 75% of the required earlier) of the subjects/papers of theory/practicals separately in Semester I.
- 3. Resolved that the admission of students in Undergraduate Semester I and III shall be opened for three days i.e. August 17th to August 19th 2015.
- 4. Resolved that the desirous students can seek admission in UG Semester I in the available subject combinations only; provided they fulfill all other eligibility conditions.
- 5. Resolved that only the students with clear pass result in Higher Secondary Part II/ any other equivalent exam, provided they fulfill all other eligibility conditions and requisite merit, shall be allowed to take admission in UG Semester I.
- 6. Resolved that under no circumstances the requisite merit (cut off percentage) for admission of students in UG Semester I shall be lowered.

- Resolved that in the next academic session new subject combinations may/shall be introduced for promoting less opted subjects (Sanskrit, Punjabi, Urdu, Dogri etc.) by the students.
- 8. Resolved that no admission in UG Semester I shall be made in the practical subjects except for those meritorious students who have secured more than 75% marks in Higher Secondary Part II; the meritorious students may be granted admission as special cases. The council further authorized the principal of the college to grant admission to the outstanding students based on their merit.
- Resolved that on urgent matters, the Chairperson is authorized to take decision on behalf of the Academic Council members (External).
- Resolved that the college should propose a fee structure which may be sent for approval through agenda by circulation.

#### Suggestions by the members:

- Dr. Ghanshyam suggested that all the stakeholders should know about the functioning of the college.
- Mr.Annil Suri urged that there shouldn't be any ambiguity in the language of notification (regarding admission) issued by the college. He also suggested that college should have its own admission policy.
- Mr. Rakesh Gupta was of the view that the college should adhere to the rules and dates laid down by the
  University of Jammu regarding admissions. He also stressed on the need to strengthen the communication skills
  of students, as it is the most important of all life skills.
- Prof. Lokesh Verma was of the opinion that the college should think of framing its own rules and regulations after thorough deliberations.
- · Prof. M.K. Jyoti suggested that the college should not deviate from government policies.

### Suggestions by the members:

With reference to Item no.8, Prof. Deshbandhu, Prof. Lokesh Verma, Prof. Rajnikant, and prof. Indira Rathore enquired about the relevance of reserving five marks for the attendance in the internal assessment of the students, which otherwise is not followed at the UG. & PG level examination conducted by the University of Jammu.

The Council was informed that due to the monthly Attendance sheet introduced in the college, regularity & punctuality among students have increased.

Prof. M.K. Jyoti suggested that the decision related to item no.8 should come to the Academic Council from the Board of studies.

With reference to Item no.9; Prof. Rajnikant suggested that the college should get a certificate from the agency that it has undertaken this type of work earlier also.

Prof. M.K. Jyoti and Lokesh Verma suggested that the college should thoroughly weigh merits and demerits of this activity before its implementation.

Prof. Deshbandu suggested that the Controller Examination should be appointed as per the UGC norms for Autonomous College.

Prof. Rajnikant and Prof. Deshbandu further suggested that the college should develop a mechanism to fix responsibilities.

With reference to Item no.10; the members enquired about the nature of the course; Prof. M.K. Jyoti suggested that the science students should also be encouraged to join Food and Canning course.

The Chairperson informed the council that a notice was circulated in this regard for the information of all the students of the college.

Prof. Rajnikant suggested that the initiatives taken by the college with regard to CBCS should be explained to the stake holders. He further said that in order to maintain the autonomous

status, the college has to justify how it is better than the other colleges, and students should be involved at some level in decision making, and framing new syllabi or activities.

Prof. Deshbandu also stressed upon involving students in framing syllabus also to have their representation in the Board of Studies of each subject respectively.

Prof. (Dr.) Neeraj Kumar, (Convener IQAC) explained the initiatives taken by the college in this regard.

With reference to Item no.12; Prof. M.K. Jyoti suggested that being Autonomous the college should have its own DGS&D. approved photocopies.

Prof. Lokesh, Deshbandu suggested that the college can outsource some work related to the item no.12, for smooth- functioning of the college.

With reference to the Item no.13; Prof Rajnikant suggested that this Item should not be implemented till CBCS is adopted by the college. He further said that a thorough research is required on the matter before it is implemented, so it should be deferred for a well research discussion in the next Academic Council Meeting.

The council suggested that the college should renovate and well equip its conference hall as it is an important place for holding important meetings.

The Chairperson Prof. (Dr.) Renu Goswami welcomed the suggestions put forward by the Academic Council.

- Mr. Annil Suri shared his concern about the Item No. 13 and asked college to develop a mechanism for the smooth conduct of the whole process related to Item No. 13. He further raised his concern for students' satisfaction with regard to Item No. 13, and also suggested that convener IQAC should give presentation on,
- Prof. Desh Bandhu suggested that college should outsource the process with regard to Item No 13.
- Prof. M.K. Jyoti suggested that the implementation of item no 13 should not become an earning exercise.
- Prof. Alka Sharma informed the council that after the implementation of CBCS, the whole process related to item No. 13 would be redundant.

- Prof. Desh Bandu suggested that college faculty should be one step ahead of University of Jammu by revising Syllabi of Courses of Study after every one year, since syllabi of Courses of Study in University of Jammu are revised after every three years.
- Prof. Desh Bandu raised his concerns regarding students- Teacher ratio, required infrastructure, and restriction on No. of students for taking admission in college. He asked college administration to take up the matter related to his concerns to the Higher Education Department J&K, as college would be at risk of losing Autonomous status without taking care of all these issues.
- He stressed upon the fact that to maintain the autonomous status college has to take each and every response of Higher Education Department in black & white.
- Prof. Desh Bandhu enquired about the faculty who would teach NCC and Military sciences. He also asked about the employability of students who study NCC and Military sciences. He suggested that degree in NCC and Military sciences should be at par with "C" certificate of NCC, and for that an MoU must be signed with NCC Directorate (J & K), The Home Department of Govt. of J & K, and Govt. of India to facilitate the entry of students into Military, Para-military and Police Service.
- Prof. Desh Bandhu enquired about the process of framing statutes of college, and in response to his query Convener IQAC, Prof. Neeraj Kumar informed the council that the statutes have been framed and would be placed for review in the 2<sup>nd</sup> Governing Body meeting, as college is shifting to CBCS from the semester system. Prof. Neeraj Kumar also replied that the vacancies of teachers for teaching NCC and Military sciences will b€ advertised in print and electronic media. Directorate of NCC (J&K) shall also be asked to send some teachers on deputation to teach NCC and Military sciences in college. She also said that college has already decided to sign an MoU with the concerned departments.
- Prof. Indira Rathore stressed upon the involvement of admission committee in restricting the number o students for admission in various courses of studies.

- Prof. Alka Sharma suggested that a separate 3-Months Certificate Course in Tie and Dye should be introduced for the aspirants, as it will be a step forward in making College self sustaining.
- Council was of the opinion that course in "Waste Management" and other Job oriented courses should be introduced under Community College Scheme.

  committee will be considered as final verdict. He said this decision
  of special speed up re-evaluation procedure.
- Prof. Lokesh Verma suggested that to develop this mechanism, college should keep time line to show papers of different subjects and different semesters on specific date.
- Dr. Hemla Aggarwal (Chairperson) said on suggestion of Worthy Members, college will start a new mechanism for Re-evaluation system on trial basis with minor subjects.

### Item No. 6.5

- Chairperson Dr. Hemla Aggarwal informed the members that the Department of Home Science has been running post graduate course successfully for the last 13 years and soon want to start Ph.D Programme in CRME from next session.
- Prof. Jooral shared his concern about Item No. 6.5 and enquired about how many No. of permanent faculty (Associate professor and Assistant Professor) in the Department of Home Science.
- Prof. M.K. Jyoti suggested that college should start the programme by completely adhering to UGC Guidelines. This suggestion of his was pressed upon by Prof. Jooral and Prof. Meena Sharma.
- Prof. Indira Rathore suggested that the faculty (2 Associate Prof. and 3 Assistant Prof.) who would be holding Ph.D course with their scholars should not be transferred, till course in not finished.

She also informed that this is a standard procedure as per UGC Guidelines.

### Item No. 6.6

- Prof. J.P. Jooral shared his concern about Item No. 6.6 and asked how existing no of faculty and limited space, college will manage 03 new post graduate programmes.
- Chairperson, Dr. Hemla Aggarwal, informed the members that the Departments who want to start P.G. have big No. of faculty members with maximum Ph.D College with soon have new block with 10-12 class rooms. Moreover, each P.G. Programme will give admission to 10 students with good merit.
- Prof. M.K. Jyoti appreciated the decision of College to begin P.G.
   Programmes from Next Session.
- Prof. Lokesh Verma said that College should revise percentage criterion from 36% - 40% to seek admission in MCA, as it is one of the most prestigious course.
- Prof. Indira Rathore advised that the teachers who will be involved in P.G. Programmes should not be transferred for atleast 02 years.

### Item No. 6.8

- Chairperson Dr. Hemla Aggarwal, informed the members of council that syllabus of Item No. 6.8 has already been sent to Dr. Nidhi Trehan, Incharge apparel designing, Sector Skill Council and she will revert by email with her suggestions regarding the required content of the said course that will fill the gap.
- Prof. Lokesh Verma suggested that administration of college should have good liasoning with the Incharge, Apparel designing for smooth and timely completion of the course.

### Item No. 6.9

- Mr. Annil shared his concern about Item No. 6.9 and enquired of the Chairperson if the students enrolled in these courses and passed out or UG students of the college and if college charges extra amount from them for the enrolled course.
- Chairperson, Dr. Aggarwal informed the members of the council that these courses are run under RUSA Programme with students of the college from 02 PM – 04 PM as add o courses without any extra amount drawn from students.

- Prof.M.K.Jyoti was of the opinion that one year Certificate/Diploma course in Beauty and Wellness should be introduced because it is job oriented and will help students to seek employment after its completion. In fact, for each new course, one celebrity expert who is associated with that course (in specification) can be kept as member/resource person to motivate students.
