## NOTIFICATION

### ONE TIME SPECIAL CHANCE TO CLEAR BACKLOG (Session 2016)

It is notified for the Candidates of 2016 session with Registration number 16GCPA.... having backlog(s) in three year BA/B.Sc./B.Com/BCA Semester 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> 5<sup>th</sup> and 6<sup>th</sup> where their chances or time period debar further appearances, shall be given One-time special chance to appear in their backlog papers. This shall not form the precedent. Hence, the aforementioned candidates are hereby informed to fill up their examination form(s) for the private examinations 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> (Notice for filling up of private forms for Semester 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> already notified w.e.f May 15 2022.) to be held in June 2022 and 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> to be held (Tentatively) in November/December 2022 for the deficient papers. Furthermore, such students are informed to submit an affidavit duly sworn before the First Cass Magistrate, deposing therein, that " I am appearing in the special mercy examination on the sole understanding that I would have no right to apply for re-evaluation nor would have any right to seek division improvement and that the result of the special mercy chance examination shall be binding on me . Further, that I shall not claim any mercy chance after this examination". The examination of semester 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> will tentatively be held in June 2022.

The students of aforesaid session (2016) are directed to fill up the examination forms for private 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> semester examinations by or before 24 May 2022 and upload the copy of the affidavit along with their application form. Online application forms uploaded without affidavit shall not be considered. The students of above said session who have already filled up their examination forms for the forthcoming examinations to be held in June 2022 shall submit the affidavit as detailed above along with copy of the application form in the examination section latest by June 7, 2022 failing which their candidature for the above mentioned examination(s) shall not be considered.
