Memorandum of Understanding

BETWEEN

Indian Institute of Technology Jammu and Govt. College for Women, Parade Ground, Jammu

This Memorandum of Understanding (MOU) is entered into and is effective as of **Date 15th November**, **2022** by and between the Indian Institute of Technology, Jammu (IITJMU) and Govt. College for Women, Parade Ground, Jammu (GCW Parade Ground Jammu), and shall be known collectively as the "Parties" and singularly as a "Party".

Recitals:

Whereas, cordial relations exist between IITJMU and GCW Parade; and Whereas, IITJMU and GCW Parade Ground have discussed mutual goals regarding opportunities for collaboration; and

Whereas, IITJMU and GCW Parade Ground desire to establish collaboration for the benefit of students and faculty of their respective educational institutions;

Now, therefore, the Parties enter into this Memorandum of Understanding, in order to materialize fundamental concepts regarding the collaboration.

Understanding of the Parties

In contemplation of establishment of the collaboration, the Parties agree as follows:

Article 1 (Objectives)

- **A.** To contribute further to the stated goals and objectives of both institutions (IITJMU and GCW Parade Ground Jammu) through mutual cooperation.
- **B.** To strengthen collaboration between IITJMU and GCW Parade Ground by exploring opportunities in the following broad areas:
 - 1. Visits by academic and/or other staff
 - 2. Visits by students and participation in events and activities
 - 3. Exchange of academic materials and other information
 - 4. Training and competency building programs
 - **5.** Sharing of best-practices
 - 6. Special short-term academic projects

Article 2 (Responsibilities of Parties)

- **A.** Both institutions commit themselves to identify concrete areas of academic collaboration and to explore the means to achieve a successful collaboration.
- **B.** The College officials who will have the responsibility in coordinating the Program for the parties are:

For IITJAMMU: Prof. Manoj S. Gaur

For GCW Parade Ground: Dr. S. P. Sarswat

Article 3 (Specific Collaborations)

While the parties may design and implement a range of activities under the broad framework of objectives laid out above, the IITJMU and GCW Parade Ground, Jammu have identified the following two activities where significant and mutually beneficent collaborations between the institutes are conceivable:

- **A.** The Centre for Essential Skills (CES) IIT Jammu currently offers skill-based courses in digital tools, finance, entrepreneurship, critical thinking and decision making, usability engineering and is planning to start a number of courses on culture, humanities and life skills shortly. The CES IITJMU will offer certificate courses for the students of GCW Parade Ground Jammu.
- **B.** GCW Parade Ground will offer the services of its faculty in teaching courses at IITJMU on demand basis. These arrangements shall be on mutually agreed terms.
- **C.** The GCW Parade Ground and IITJMU shall coordinate and collaborate in research activities including projects in the sciences, humanities and commerce streams through exchange of faculty, researchers and students.
- **D.** Curriculum redesign and modernization in the humanities with the support of GCW Parade Ground and sciences and engineering with the support of IITJMU shall be attempted by both parties. (The redesign and modernization of the curriculum in the streams of humanities, sciences and engineering shall be attempted jointly by both the parties.)
- E. A research centre at GCW Parade Ground is being proposed to offer Ph.D. programme and is financially supported by the HED, UT of J&K. IITJMU will provide important insights during the setup of the College Research Centre, GCW Parade Ground. The enrolled PhD students can use the research facilities of IITJMU.

Article 4 (Understanding of Parties)

- **A.** The Parties understand and acknowledge that they are making a significant commitment to this collaborative effort. Accordingly, the Parties agree to expend their best efforts on the design, implementation, and successful continuation of the collaboration.
- **B.** This MOU shall remain effective from the date of execution until the end of the term of five (5) years, at which time it will terminate unless extended by mutual written consent of the two parties.
- C. The Parties understand and acknowledge that this Memorandum of Understanding will provide the foundation for a comprehensive agreement concerning the details of the collaboration and that the parties may, if they so agree sign separate written agreements for the activities designed and agreed for implementation under this MOU.

GOVERNMENT COLLEGE FOR WOMEN PARADE:-The farsighted vision of Maharani Tara Devi with regards to dissemination of education among the women of Jammu fructified in the establishment of Maharani Mahila College on 1stJune, 1944. On 25th November, 1953 the college was taken over by the government of Jammu & Kashmir and renamed as Government College for Women, Parade Ground, Jammu. What started as a noble thought, a progressive outlook with limited outreach as initially only Arts courses were taught, has metamorphosed into an institution offering UG programmes in Arts, Science, Commerce, BCA and PG in Music, Home Sciences, Zoology, English and Computer Applications(MCA). The college through sheer dint of hard work and focused approach has evolved into an institution conscious to the aspirations, needs, and challenges (academic and employability) of nearly 6500 students presently pursuing education in about 28 subjects/courses at various levels. A rich pool of resource persons (96 permanent faculty + round about 40 faculty on contact basis and guest faculty) and creative leadership right through the inception till date has concertedly toiled to build the infrastructural (academic and physical) facilities with the aim to achieve academic excellence and cater to the needs of diverse student community of the college. The college over a period of more than seventy years of its establishment has built a reputation of being the best academic institution for women in Jammu & Kashmir state as is indicated by the facts, that it was re-accredited as 'A' Grade by NAAC in 2011, granted Autonomy and CPE (College with potential for excellence) status by UGC in 2014 and 2016 respectively.

DOGRA DEGREE COLLEGE:- Established in the year 2008 is a primer institute imparting education in areas of Business Management, Commerce and Humanities. Besides being recognized by the Govt. of Jammu and Kashmir and affiliated to University of Jammu, this College is also ISO 9001:2015 certified. The College is recognized by the University Grants Commission under section 2f of the UGC Act, 1956. Dogra Degree College has distinct community oriented objectives to translate the vision and mission of the institution into reality. The College is a part of Dogra Group of Colleges being run under

Government College for Women Parade, Jammu, J&K-180001- India & Dogra Degree College, Bassi Kalan, Bari Brahamana, Jammu, J&K-181133-India have agreed upon to enter into an understanding for working under a mutually cooperative dispensation with regard to the following objectives

- 1. Student exchange Programmes.
- 2. Exchange of the best practices.
- 3. Exchange of the research activities.
- 4. Consultation and support in the development of Infrastructure.
- 5. Consultation and support in handling classes through online platforms.
- 6. Consultation and support in development of IT based infrastructure.
- 7. Consultation and support in preparation for NAAC.
- 8. Consultation and support in e tendering process.
- 9. Support in any other facet, wherever and whenever any of the institution feels the need.

This agreement is an understanding between these two institutions to facilitate each other in the above referred areas and shall not in any way make any of the institutions liable for legal or departmental explanations arising out of

- a) Any deliration in the primary duty of each institution at its own end.
- b) Any financial irregularity
- c) Any legal involvement.
- d) Any issue stemming out from non-compliance of the official or legal directions.

This understanding is initially for a period of three years the first day shall be the date of signing this document.
